HELP US HIGHLIGHT THE MAJOR CHILDCARE SHORTAGE IN D9

Locally we have a perfect storm; a real shortage of places, early years workers struggling to afford to stay in the job they love, and small local providers struggling to keep their doors open. Last year, we saw **the loss of 105 pre school places in Stoneybatter area** and before that, we saw **the closure of a Montessori and afterschool in Drumcondra with the loss of 40 places**.

In our childcare survey last year, **one in every three surveyed parents told us they were waiting 12 months or more to find a childcare space** for their child. This is shocking. Far too many parents have been forced to put their careers on hold or reduce hours, particularly working mothers.

KEEPING OUR COMMUNITIES SAFE

Despite the excellent efforts of local Gardaí, there is a serious lack of visible policing. Unfortunately, we have too few community Gardaí and they are stretched too far. We have 23% fewer community Gardaí in the Dublin North Central area compared with a decade ago.

Re-opening the Phoenix Park Garda training college and prioritising community policing are crucial to turning this around. I'm fighting for this as your local Senator.

Across communities, if there are repeated incidents we are happy to organise meetings between Gardaí and local residents.

Over 50 artist spaces have closed in Dublin over the last decade and many of those remaining are under enormous financial pressure. **When competing against commercial interests, artists' spaces don't stand a chance.** That needs to change.

CHANGE THE LAW TO MAKE MORE HOMES AVAILABLE FOR PURCHASE

Within 2km of where you live now, there are 270 houses lying vacant long-term*.

Every single one of these could be a home, if the political will was there. **The State's current hands-off approach to abandoned buildings is a disgrace.**

We need:

- A **higher and more effective tax on vacant** and derelict properties.
- Stronger compulsory purchase laws to allow the **Council to take over long term vacant homes**
- Reformed planning and stamp duty laws to **ensure apartments are sold to individuals and families**, not just asset funds. Two years ago, Government moved to protect the sale of houses only, not apartments. Apartments are the future of living in Dublin!

There are some increases in social housing units coming to the Dublin 9 and Dublin 3 area. There are currently no plans for affordable purchase or cost rental projects.

- Daneswell Place, Botanic Road: 160 units. Likely purchase by Co-operative Housing Ireland for social housing. Due for completion date 2026.
- Orchard Terrace: 37 new social units. Completion due 2026.
- 194-198 Clonliffe Road: 33 new social units. Completion due 2026.
- 8 & 10 Ferguson Road: demolition and rebuild planned. Completion due 2025.

WASTE COLLECTION SYSTEM – TIME FOR CHANGE

Our communities face the ongoing scourge of illegal dumping, massive frustrations about street cleaning and a patchy waste collection service.

I believe we need to change who collects and processes waste in our city.

We need these changes so that **investment can be made** in

- **Shared collection points**- available widely across communities
- **More recycling and composting facilities**- easily accessible and open for extended periods.

To do this, we need to start with a **single, reliable bin collector for the whole city – one that can be held to account.**

Private bin companies are creaming profits from household collection while Dublin City Council is left to clean up the mess and is expected to provide recycling and composting facilities. Such is the dysfunction that new laws about mandatory brown bin collection cannot be rolled out in the inner city as many streets are bag only.

In May, we got cross-party support in the Seanad for our plan to reform waste collection.
